TERMS and CONDITIONS

Dear Valued Customer,

Agri Fresh Logistics currently services, Toowoomba – Brisbane, Brisbane –Toowoomba, Ipswich, Rosewood, Laidley and Gatton daily Monday to Friday. We also service Lowood and Esk when required. **Freight bookings will need to be advised by 4.00 pm for pickup and delivery the next day.**

Agri Fresh Logistics refrigerated vehicles are **accredited with Safe Foods Queensland** and employ advanced technology in the form of satellite tracking, temperature, tyre and camera monitoring and are regularly scrutinised by external auditors to ensure the highest standards are met for our customers peace of mind.

Agri Fresh Logistics undertakes Freezer, Chillier and Dry freight movements for many reputable brand names and has excellent communication with its current customer base.

Agri Fresh Logistics Pty Ltd is not a Common Carrier and therefore dose not insure Customers Goods for loss or damage of stock. Insurance of Goods whilst in transit with Agri Fresh Logistics is the responsibility of the Customer.

Our Pricing:

Space/Pallet Charge: One space is defined as 1.2m x 1.2m square with the *maximum* height 1.8m. One space is not to weigh over 950kg (including the pallet or pallets).

Cost per Pallet/Space: As per Customer rate.

Fuel levy: 10%

Fatigue/Compliance Levy (Inc. toll charges/fatigue management fees): will be passed on at a charge of **\$5.00** per pickup.

Booked in/Not available Fee: \$35.00

If a booking is made and upon arrival the product is not or will not be available for pick up, the driver will fill in an Agri Fresh Logistics docket for the product not being available.

Standby/Waiting Fee: \$45.00 per 30 mins.

All drivers will wait up to 20mins before being loaded at no charge, after the first 20 minutes the standby fee will be charged in 30 min increments.

Return pallet charging: \$30 pickup and storage fee.

Hand Unloading Fee: Additional **\$20** per consignment.

Trading Terms: 7 Day accounts.

Credit Limits: All customers will have a credit limit applied to their account.
